

You are Invited to Participate in the Ninth Annual Art Source Gallery Juried Show-- July 2010

Important Dates:

- May 15: Deadline for receiving submissions, entry form and \$25 jury fee.*
- June 7: Notification of jury results mailed to artists.
- June 23-26: Hand delivered work accepted at Art Source Gallery from 10am – 5:30pm.
- June 26: All accepted works must be received at the Art Source Gallery.
- July 1: Opening reception, 5-9 pm. Awards announced at 6:30pm. Show runs through August 1.
- August 2-4: Return of artwork. Pick up all hand delivered entries between 10am and 6pm.
- August 9: All remaining work will be shipped at the artists' expense.

Awards: The Best-of-Show and Runners-Up award recipients will receive cash awards totaling \$1000.

Juror: John Taye is a Professor Emeritus at Boise State University where he taught for 33 years. He taught a variety of drawing, painting and sculpture courses there, as well as workshops at numerous other schools. Taye has had over two dozen solo exhibitions throughout the West, and he has shown in many invitational and juried exhibitions throughout the country. He is a Fellow in the National Sculpture Society, New York City, and has exhibited his work there in numerous shows since 1989. In all of his work he tries to emphasize a positive, affirmative view of life, and an appreciation for the intricacies and beauties of the natural world.

Eligibility: The exhibit is open to all fine artists and media (no video or crafts). All work must be original and completed within the last three years. Artists may submit up to 3 works of art. Three dimensional works are limited to 75 pounds. Any accepted work that differs from the image will not be displayed.

Shipping and Return: Shipped entries will be received at Art Source Gallery June 21 through June 26. Artists are responsible for all shipping costs and art work must be sent in cartons or crates suitable for return COD by UPS. No packing peanuts, please. Entry information (artist, title, price) **must be attached** to the back of each piece. Please enclose a **typed return address label** and enclose a note as to whether or not you wish to have insurance on return shipping and the insurance value. If you do not indicate whether or not you want insurance on return shipping, we will add it at your cost. If you want to arrange for alternative shipping (rather than COD from us), please arrange it prior to sending your work, and enclose a note as to the specifics.

Sales: Sales are encouraged (but not mandatory). A 30% commission will be retained by Art Source Gallery on sales. Artists will be mailed a check within 30 days after the sale.

Digital Images: You may submit up to three different entries in digital form, either as a CD mailed with your registration, or as images emailed to bbowling@cablone.net. See the checklist on page 3 for digital submission guidelines. Please include only one image per 2D entry, or up to 2 for 3D entries. CD's will not be returned, but will be destroyed after downloading.

Jury Fee: The \$25 jury fee is for *up to* three different entries. The *total* amount you submit for 1-3 entries is \$25.

Liability: All possible care will be taken with your pieces while in our Gallery, however Art Source Gallery and its agents will assume no liability for damage or loss. You are advised to carry your own insurance on your work. Any claims against the shipper are the responsibility of the artist.

Checklist for Art Source Gallery Juried Show

Entries must be received by **May 15, 2010**.

- ◇ Digital images should **not exceed 1 MB/image and be in a jpg format**.
- ◇ Label your CD with your name. For individual file names, do NOT include your name, but include the title of the work, medium, dimensions and date completed. (e.g. Best Friend, vitreous enamel over steel, 10" X 10", January 2010).
- ◇ Submit CD to Art Source Gallery 1015 Main Street, Boise, ID 83702 OR email images to bbowling@cablone.net **prior to May 15th**.
 - Include the entry form and the \$25. jury fee. If you are emailing the images, mail the entry form and jurying fee separately to Art Source Gallery, and indicate that the images were emailed.

If your artwork is accepted:

- ◇ Attach the entry information (artist, title, price) to the back of each piece
- ◇ Enclose a **typed return address label** and enclose a note as to whether or not you wish to have insurance on return shipping and the insurance value. If you have arranged alternative shipping, please include it in this note.
- ◇ Deliver all art work to the Art Source Gallery **between June 23rd and 26th**. If delivering in person, the delivery hours are between 10am – 5:30pm. If you need alternative delivery arrangements, contact Barbara at bbowling@cablone.net.
- ◇ **July 1st**: Opening reception, 5-9 pm. Awards announced at 6:30pm.
- ◇ **August 2nd-4th**: Pick up all hand delivered entries between 10am and 6pm.
- ◇ **August 9th**: All remaining work will be shipped at the artists' expense

2-D WORK MUST BE FRAMED OR GALLERY WRAPPED AND HAVE A WIRE ATTACHED FOR HANGING. OTHERWISE IT WILL NOT BE HUNG. NO SAWTOOTH HANGERS WILL BE ACCEPTED.
